Deadline for Contestant Registration Friday, October 7, 2011 - 9 pm



Each contestant in the Mr. BARRACKS Leather 2012 contest:

- a) Must be available for the Contest weekend, October 7, 8 and 9, 2011
 - b) Must be at least twenty-one years old.
 - c) Must be male.
 - d) Must be of same-sex orientation
 - e) Must have a demonstrated interest in leather, and/or fetishes, as determined by the judging panel.
 - f) Must agree to appear onstage wearing appropriate leather and fetish gear.
 - g) Must own all leather clothing worn onstage during the contest.
 - h) Must agree to represent The Barracks Bar title, if he wins, throughout his title year and represent The Barracks in the Mr. Palm Springs Leather 2012 contest.
- Friday, October 7, 2011 - Meet & Greet - 10 pm
 - Saturday, October 8, 2011 - Pre-Judging - 1 pm and Contest (arrive 9 pm)
 - Sunday, October 9, 2011 - Victory Beer Bust

WHAT IS EXPECTED OF TITLEHOLDERS

Mr. BARRACKS Leather 2012 must conduct themselves in proper leather protocol and dress at all times during their title year. Flagrant violation of this policy may result in forfeiture of the title. Mr. BARRACKS Leather 2012 will be required to organize and participate in fundraisers for a local not for profit group. Mr. BARRACKS Leather 2012 will be strongly encouraged to participate in fundraisers for other charitable causes as well.

Judging Method

Mr. BARRACKS Leather 2012 contestants shall be scored by panel of judges using a straight scoring system in the categories and points outlined below:

- a) Interview - Maximum 150 points - Each contestant will meet with the judging panel offstage prior to the contest to answer the judges' questions about the contestant's interest in leather and fetishes, knowledge, community and willingness and ability to represent the title.
- b) Casual Cruise/Bar Wear – Maximum 50 points - First introduction on stage. Contestant will be introduced as the biography is read.
- c) Physique/Jockstrap - Maximum 50 points - Each contestant shall appear onstage in body-revealing attire which emphasizes his best physical feature.
- d) Formal Leather Image - Maximum 50 points - Each contestant will appear onstage to introduce himself to the audience and briefly describe his background or interest in the leather community, while wearing the attire that best represents his image of a Leatherman. Contestant will answer question(s) on stage.

The contestant whose score is highest will be declared as the winner. The contestant whose score is second highest will be declared as the first runner-up.

A winner and first runner-up shall be selected for the contest. In the event of any dispute regarding the tallying of a contest, the contest producer shall assist the contest judging panel to resolve the dispute, but the contest sponsor shall make the final determination of the winners.
